SECTION 3 - HAZARDS IDENTIFICATION

*** EMERGENCY OVERVIEW ***: Non-hazardous under normal use conditions.

EFFECTS OF OVEREXPOSURE - EYE CONTACT: This material is not expected to be irritating to the eyes. However if direct eye contact should occur, flush with water for 15 minutes. If irritation should develop and persist then consult a physician.

SECTION 3 - HAZARDS IDENTIFICATION

EFFECTS OF OVEREXPOSURE - INHALATION: This material has a low vapor pressure and is not expected to present an inhalation hazard. However, if the TLV of 5 mg/m³ is exceeded then inhalation of mists or vapors may cause a mild irritation of the mucous membranes of the upper respiratory tract.

EFFECTS OF OVEREXPOSURE - INGESTION: No hazard in normal industrial use.

EFFECTS OF OVEREXPOSURE - CHRONIC HAZARDS: None known.

SECTION 4 - FIRST AID MEASURES

SECTION 6 - ACCIDENTAL RELEASE MEASURES

STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED: Absorb spill with inert material (e.g. dry sand or earth), then place in a chemical waste container. Avoid runoff into storm sewers and ditches which lead to waterways.

STORAGE: Keep away from heat, sparks and flame.

SECTION 8 - EXPOSURE CONTROLS/PERSONAL PROTECTION

ENGINEERING CONTROLS: Local exhaust ventilation may be necessary to control any air contaminants to within their TLVs during the use of this product.

RESPIRATORY PROTECTION: A respiratory protection program that meets OSHA 1910.134 and ANSI Z88.2 requirements must be followed whenever workplace conditions warrant a respirator's use.

SKIN PROTECTION: Not normally required. When splashing or liquid contact can frequently occur, good hygiene practices dictate the use of oil resistant gloves and/or other protective clothing.
